3 Columbia Fencers Advance ToN.C.A.A.Semi-Final Round

RALEIGH, N.C., March 27— Columbia University began its drive to retain its National Collegiate fencing championship today by advancing all three of its fencers into tomorrow's semi-final round.

Tony Kestler in foil, Michael Braun in épée, and Daniel Gottesman in saber, were among 72 qualifiers, 24 in weapon, who remained after today's opening round. Eight colleges were eliminated and 26 others knocked virtually out of contention for team honors in the 25th annual tournament, which began a three-day run at North Carolina State University's Reynolds Coliseum.

The Lions had a hard time in becoming one of 10 colleges to have all three of its fencers move into the second round, Columbia of the none swordsmen had a really good

Kestler finished fifth in his pool, with a 5-4 won-lost record to gain his spot in the semifinals. Braun picked up the fourth of five slots in his pool with a 5-4 performance and Gottesman was 5-3 in a saber pool.

One of Gottesman's victories was over Ray Keifetz of City College of New York, the Eastern saber champion. The 5-3 defeat was the Beavers' only

loss in eight bouts.

Keifetz's two teammates also qualified for the second round, Jean-Claude Castiel with a 6-3 Simon foil. and record in Alscher with a 4-5 compilation in épée.
